## DOG REGULATIONS AT THE BEACH

In compliance with the health ordinance of the Department of Veterinary Public Health of Emilia-Romagna, access is allowed only to small and medium-sized dogs, which are not dangerous and which do not cause public nuisance.

Dogs can only enter the beach with a health certification (vaccination booklet or other similar health document) attesting that vaccination has taken place for not less than 20 days and not more than 12 months for: **distemper**, **canine infectious hepatitis**, **leptospirosis** and particularly **echinococcosis** (deworming) treatment for not less than two days and not more than twenty days.

It is forbidden for dogs to stay outside the authorised area, in particular **dogs must** NOT access the sea, the children's playground and the shower area.

## THEY CAN ONLY STAY UNDER or AROUND THE PARASOL.

Access is prohibited to dogs which are subject to restrictive public safety provisions and which, by temperament or character, proved to be dangerous or causing public nuisance. Access is also forbidden to females during an oestrous cycle.

Guests are provided with the usual beach equipment and a bowl for watering the animals; it is the owner's responsibility to find the best arrangement for their animals within their personal parasol area.

Dogs must be kept on a leash, and owners must ensure the safety and tranquility of other quests at all times.

In the event of incompatibility between dogs and other guests or in case of disorderly conduct by their owners, the Management reserves the right of immediate removal from the beach.

Guests must take their dog for walks (outside the lido) at least every two hours; in case of droppings on the beach they must collect them immediately, using a shovel and putting them in special bags that must be closed and thrown into the waste bin.

Insurance for damage to third parties is welcome.

Dog access to the beach IS LIMITED and costs € 2 per day.

## Access is allowed to these dog breeds:

• Examples of **small dogs**:

Affenpinscher, Dachshund, Bolognese, Poodle, Chihuahua, Welsh Corgi, Dandiegordon Dinmont, Fox Terrier, Jack-Russell Terrier, Brussels Griffon, Yorkshire, Maltese, Pekingese, Italian Greyhound, Pinscher, Dwarf Schnauzer, Sealyham Terrier, Skye Terrier, Scottish Terrier, Volpino and similar.

• Examples of **medium-sized dogs**:

Medium poodle, Bassethound, Beagle, Bedlington, Chow-chow, Cirneco dell'Etna, Cocker Spaniel, Epanieul, Griffone, Kerry Blue, Medium Schnauzer, Hound, Irish Terrier and similar.

 Examples of large dogs, ONLY ADMITTED if the owner/keeper is in possession of a certificate issued by a Veterinary Doctor which shows the docile nature of the animal and the ability of the owner/keeper to guarantee a correct conduct:

Airedale Terrier, Great Dane, Bloodhound, Boxer, Bracco, Dalmatian, Doberman, Great Swiss Mountain Dog, Labrador, Afghan Hound, Russian Greyhound, Belgian Shepherd, Bergamasco Shepherd, Maremma-Abruzzo Shepherd, Scottish Shepherd (Collie), German Shepherd, Pointer, Riesenschnauzer, Rottweiler, St. Bernard, Setter, Spinone and similar ...
